

Mail Box Thefts

Mail thefts in Vallejo and cities nationwide spike during tax season. Here in Glen Cove in late July a woman was arrested on South Regatta with mail from 4 different residences. In early September, a couple with a

mailbox master key continuously robbed a group or "gang" box, but alert neighbors got a license plate number and descriptions. Now the Postal Inspectors office is pursuing this case with vigor. anyone has any footage of any mail theft on their home security cameras, please contact him. Lastly, it is advised that mail theft victims should contact one of the three major credit bureaus to check for any fraudulent activity (free yearly credit report) and check credit cards and bank accounts for any unusual activity.



Foul Odor in South Vallejo

The City of Vallejo communications operators began receiving calls for service around 7:15 p.m. on Tuesday, September 20, 2016, with reports of an unknown odor primarily centered in South Vallejo, situated just north of the Carquinez Straits and on the eastern shore of the San Pablo Bay. Due to the unknown cause of the odor, the City issued a shelter in place order and Public Safety per-

sonnel were dispatched to investigate the source of the odor with the support of PG&E. As the evening progressed, the odor seemed to dissipate evidenced by both fields tests and a decrease in the volume of calls into the communications center. The shelter in place order was lifted on Wednesday morning at 6:00 a.m. and it was later confirmed that two sheens, possibly oil, were present. We were then later informed about a leak that was found across the waterway at the Phillips66 refinery. To date, no entity has shared any information with City officials about a possible cause of the unknown odor.

PB Concludes the Idea Collection Phase

Participatory Budgeting concluded the idea collection phase on Monday, October 3, after a four month submission period. A total of 856 ideas were submitted and can be viewed online. The Steering Committee reviewed ideas at the Steering Committee meeting on Thursday, September 15, and created three categories based on the type of ideas: Quality of Life (354 ideas), Programs & Services (255 ideas), and Public Safety & Infrastructure (248 ideas). All ideas submitted will be forwarded to Budget Delegates as they consider which ideas to develop into project proposals for the April 2017 PB Ballot. The City and the Steering Committee would like to thank all of the Vallejo community members who participated in the idea collection phase!

<u>CITY OF VALLEJO</u> <u>REOPENS APPLICA-</u> <u>TION PERIOD FOR</u> <u>CULTURE & THE</u> <u>ARTS COMMISSION</u>

The City of Vallejo is reopening the application period for the Commission on Culture and the Arts to garner specific interest from members of the City's diverse cultural institutions and communities. Vallejo residents who are passionate about preserving and celebrating Vallejo's culture are invited to submit an application and supplemental questionnaire for consideration. The Commission on Culture and the Arts was recently reestablished after a seven year hiatus. All seven seats are open for selection by the City Council. The purpose of the Commission is to provide advice to the City Council on items relating to arts and culture, such as a plan for the placement of public art and how to support cultural events. Mayor Osby Davis noted that "we had an amazing response from our Arts community, and we appreciate all the individuals who stepped up to apply. The City Council wants to make sure that the Commission also represents our rich cultural heritage, and for that reason asked to reopen the application period before we make a decision. All you have to do is look at the amazing festivals in Vallejo to see that we are home to phenomenal cultural groups, and we want to make sure they are part of the discussion." To be eligible for appointment, applicants must be residents of the City of Vallejo. Information regarding the duties of the Culture & the Arts Commission may be found in the application materials. Appointments are typically for a term of four years. Applications must be received no later than close of business on Friday, October 28, 2016. Applicants must attend the interview with City Council in order to be considered for appointment. Become A Master Gardener

If you enjoy growing ornamental plants or vegetables, like to increase your knowledge of horticulture, are committed to community service, and have the time, consider becoming a Master Gardener. The mission of the program is "to extend to the public research-based information, verified by UC researchers, about home horticulture, pest identification, landscape maintenance, and other environmental issues." Master Gardeners are volunteers who provide information to the public in a variety of ways.

In order to become a Master Gardener, you must participate in a semester-long (January through April) training program consisting of classes that meet on Fridays for four hours. Class topics may include: water management, weeds, grasses, vegetable gardening, insects, landscape trees, and fruit tree management. Once the training is completed new Master Gardeners must volunteer for 50 hours during their first year. Volunteer activities include, but are certainly not limited to, collecting branches and assisting with the annual wreath workshop, tabling at Farmers' Markets, writing blogs for Under the Solano Sun or articles for Seeds for Thought, volunteering for the annual Vallejo Garden Tour, giving presentations, assisting with the annual plant exchange, and working on the Master Gardener booth at the Solano County Fair.

After the first year Master Gardeners volunteer for at least 25 hours plus participate in continuing education activities for 12 hours annually. These activities may include taking horticulture classes, attending gardening seminars, or researching information for blogs or articles.

Many of my volunteer hours are earned by tabling at the Vallejo Farmers' Market at the corner of Georgia and Marin Streets from 9 am until 2 pm on Saturdays. There are usually three Master Gardeners present who provide printed information and answer questions posed by members of the public. I enjoy interacting with the people who are usually plant lovers and learn a great deal from them and the other Master Gardeners. As you can tell, there are a variety of activities in which to participate and it is up to the individuals to determine which ones they wish to complete.

If you love growing plants and enjoy talking with people with similar interests, becoming a Master Gardener is probably right for you. No previous horticultural experience is required to be accepted into the program. The Fence Along South Regatta Drive

As you drive along South Regatta Drive and look toward the water you will see an ageing wire fence with wooden posts. You may notice that portions of the fence are leaning severely and are an eyesore while other sections are in good shape. The best sections are the result of relatively recent replacement due to cars driving through the fence with the drivers' insurance footing the repair bill. In other places the fence looks all right but the posts are rotted and loose.

Members of the Glen Cove Community Association have been in discussions about the condition of the fence with California State Parks staff for most of this year. There is a question about jurisdiction, that is, does the fence lie on State Parks or City of Vallejo land? State Parks Sector Superintendent, Ryen Goering, who has oversight responsibility for Benicia State Recreation Area and much of the land along South Regatta Drive, has requested that State



Parks surveyors add this fence to their list of projects in order to determine if it's on State Parks land. In the meantime, Mr. Goering stated that they will reinforce the leaning posts with metal T-posts in order to improve the look and safety of those sections of fence. In addition, he has spoken with a maintenance staff member with the City of Vallejo who stated that the City is not maintaining fences on its property or Landscape Management District land.

In an email to concerned residents, Mr. Goering stated that the fence was initially constructed by Kauffman and Broad during construction of the adjoining subdivision in order to stop 4x4 vehicles trespassing on State Parks property from the construction site. Also, the fence served to decrease the amount of trash from construction that ended up on the park property.

Mr. Goering has suggested the possibility of replacing the six-foot, wire fence with a lower, less expensive split rail fence. If you take the trail over the hill to the State Park you will see the split rail fence that was recently repaired by volunteers. Replacement of the current fence along South Regatta Drive with a split rail fence raises a number of questions. The current fence provides a barrier that limits access points to the open space land along the strait thus minimizing the number of "volunteer" trails that exist. Although the fence is not impenetrable, it does provide a barrier that may keep pets and wild animals such as coyotes separated. It helps to preserve the habitat for pheasants and other wild creatures that live there. If the current fence were replaced by split rail or, taking the discussion further, no fence at all, it would certainly change the look of the area and open up the parkland to greater access. In addition, it could be argued these two possibilities might be more attractive than the current fence, even if it were in excellent condition.


