Vista Cove Moves Forward

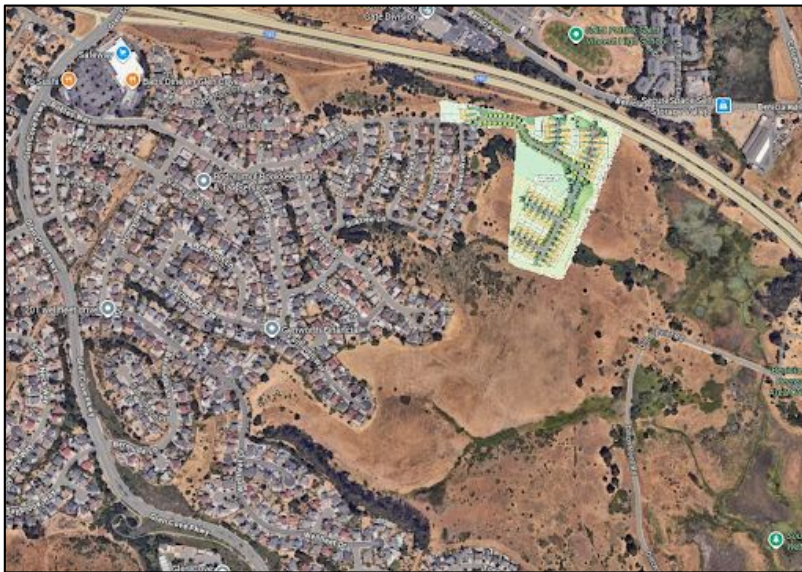

Update on Proposed Vista Cove Housing Development

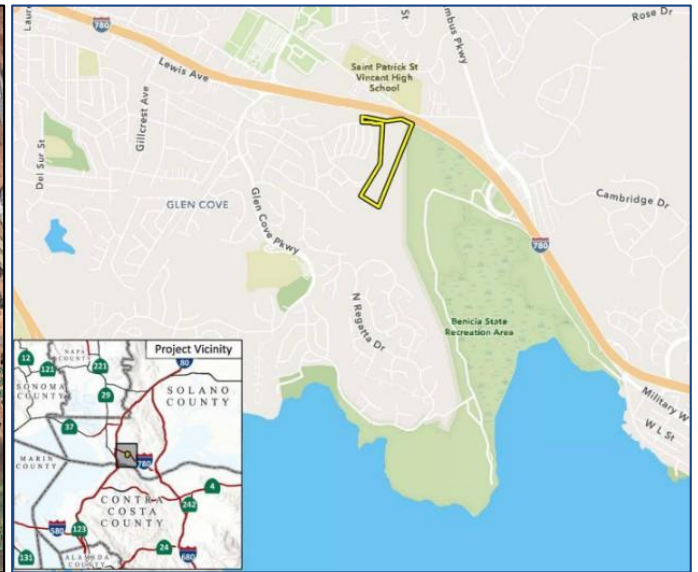
If you've been following this newsletter, you may have seen my previous articles on the proposed housing development of 51 single-family homes on undeveloped land located between Wildflower Avenue and the Benicia State Recreation Area.

The section of land, approximately 20 acres, has been zoned Medium Density Residential (MDR) since the 1970s, when the City was planning for the housing developments that eventually became our Glen Cove community. Under the current zoning code, the property could legally support significantly higher density—potentially hundreds of multi-family units such as condominiums or townhomes.

The project applicant, [Sancerra](#), is proposing to construct 51 single-family homes on roughly 10 acres of the site closest to Interstate 780. The remaining southeastern portion—approximately 10 acres with steep slopes—is proposed to be preserved as open space, with the stated intent of restricting future development in that area.

On Wednesday, January 21, the **Vallejo Planning Commission** met to review the project. This meeting was originally scheduled for December but was postponed at the City's request to allow additional internal review.

During the January meeting, a number of residents raised concerns about traffic flow, road conditions, restricted emergency access, loss of natural open space and wildlife habitat, and potential impacts on both Glen Cove residents and visitors to the adjacent State Recreation Area. Two local real estate agents spoke in support of the project, citing strong demand for housing in Glen Cove and limited inventory in our neighborhood.

At the conclusion of the meeting, the Planning Commission voted 4–2 to approve the project. A recording of the meeting, along with approximately 2,000 pages of project documents and supporting materials submitted by the City and the developer, is available for public review on the City [website](#).

The project now moves to the next phase, which will require rezoning approval by the Vallejo City Council. This meeting is tentatively set for March 24th. Interested parties will be notified once the date is confirmed. To register as an interested party, contact cesar.orozco@cityofvallejo.net.

Meet Our Glen Cove Neighbor

My name is Satish Chohan and my wife is Surekha Chohan. We live on Chesapeake Drive in Glen Cove, Vallejo.

In 1998, I moved to the Bay Area, where I met my wife at a small gathering. It was love at first sight and we were married several weeks later. We have been happily married for 30 years. We have six grandchildren—two in Colorado, two in Sacramento and two on the East Coast. In Benicia in 2007, I acquired a small manufacturing business and expanded into precision



manufacturing company serving Silicon Valley. Over the years, I have authored technical papers and secured engineering patents.

Surekha Chohan is a retired dentist who practiced family dentistry in neighboring Benicia for 20 years. She is currently serving as a part-time dentist devoted to Medicare patients, and is in charge of review and guidance for oral surgery.

In my spare time, I enjoyed racquetball and following current affairs. Glen Cove has been home for decades, and I look forward to learning more about your journey that brought you here.

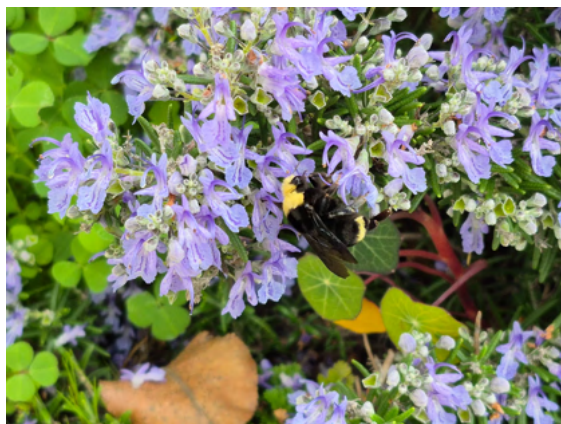

Vallejo Garden Tour 2026

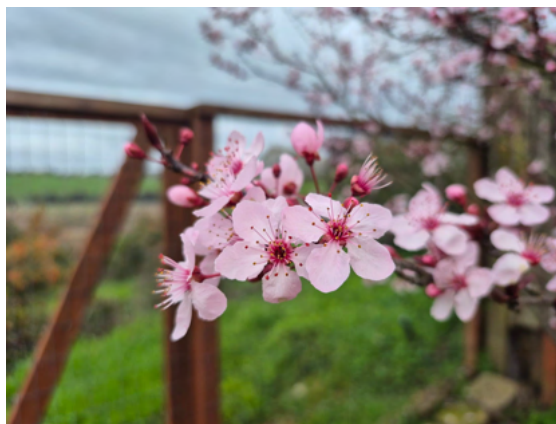

The 23rd annual Vallejo Garden Tour will take place on Sunday, May 17. It is a fundraiser for the Vallejo Naval and Historical museum located downtown. The museum is a repository of historical artifacts that document the long history of Mare Island Naval Shipyard and the city of Vallejo. It holds a variety of community events including art exhibitions, concerts, programs for school children, and much more. On the second floor of the museum, there is a periscope that protrudes out the roof of the museum, and from which there is a 360 degree view of the vicinity.

This year's garden tour features nine gardens scattered all over Vallejo. The garden that is furthest north has a view of the Napa River and is adjacent to the Meadows neighborhood of Vallejo. One of the mansions on Mare Island and its beautiful garden are part of the tour as well. Of special interest to members of the GCCA are the three gardens located in different parts of Glen Cove.

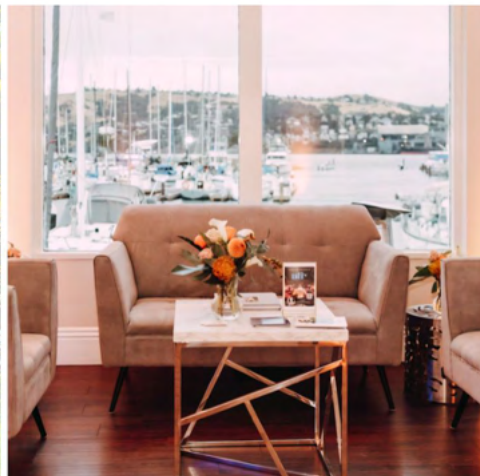

Residents, Conservation Groups, and Patwin Tribes Working Together to Steward Cultural Land at Glen Cove Waterfront Park

As spring blooms begin to appear, visitors may notice an increase in wildflowers at Glen Cove Waterfront Park. Since 2021, the Park has been the focus of a native habitat restoration project funded by the Yocha Dehe Wintun Nation, made possible through collaboration with conservation partners and the Glen Cove community.

Today, Glen Cove Waterfront Park offers neighbors and visitors alike a place to run, walk our dogs, fish, connect with nature, or simply enjoy a breath of fresh air. Whether watching the sunrise over the Carquinez Strait or pausing to listen to birdsong beneath a blooming tree, the Park invites moments of reflection and connection. On any given day, visitors might spot groups of third-grade students filled with curiosity as they explore the Park through the Solano RCD's Watershed Explorers Program, or join smiling volunteers from the Vallejo Watershed Alliance as they plant and care for restoration areas. Each visit is an opportunity to engage with this living landscape shaped by shared stewardship and woven with the stories of all who cherish it —work that will be celebrated in 2026 as the community reflects on years of collective effort.

Patwin Tribes and a Historic Cultural Easement

Glen Cove Waterfront Park is located within the homelands and traditional territory of the Patwin people, where Patwin Tribes, including Yocha Dehe Wintun Nation, lived, stewarded the land, and cared for communities from time immemorial — a responsibility they continue to uphold. Today, there are three federally recognized Patwin Tribes: the Cachil Dehe Band of Wintun Indians, Kletsel Dehe Wintun Nation, and the Yocha Dehe Wintun Nation.

Because the Tribe's connection to the Park goes back generations, the relationship was formally recognized in July of 2011 through a cultural and conservation easement with the City of Vallejo.

This shift toward co-management ensured the preservation of cultural heritage and sacred sites without requiring a transfer of land ownership, while also supporting the long-term stewardship of the Park for public benefit. It allows Patwin people to safely access ancestral homelands to practice, maintain, and pass on cultural, spiritual, and traditional lifeways, while providing legal protection for this historically significant area. For Yocha Dehe and other Patwin Tribes, the protection of these places — of which there are countless within the city of Vallejo alone — is a superseding moral and familial imperative, rooted in responsibility to ancestors and future generations. Many of these important Patwin cultural sites are seen in harmony with restored native habitat.

Patwin connections to the region are deeply embedded in local history. Solano County is named after the Patwin leader Sem-Yeto, baptized as Francisco Solano, and Suisun City takes its name from the Suisunes, a Patwin tribe — reminders that the area's cultural roots remain present today.

Prior to Yocha Dehe’s involvement in negotiating the easement, the Greater Vallejo Recreation District had planned major construction, which would have disturbed cultural sites, including ancestral burials. There was public opposition to the construction, but Yocha Dehe Wintun Nation and Kletsel Dehe Wintun Nation, the “Most Likely Descendants” in Vallejo, worked closely with all interested parties, including neighboring tribes across the Carquinez Strait, to ensure the protection of the ancestors buried at the site.

Solano Resource Conservation and Glen Cove Residents

This cultural easement helped spur the ongoing Glen Cove Waterfront Park Enhancement Project. Working with the Solano Resource Conservation District (RCD), Glen Cove residents, and local volunteer groups — including members of the Glen Cove Community Association — the Project focuses on restoring native habitat while protecting important cultural resources.

Over the past few years, the Solano RCD, area residents, and other volunteers have removed noxious plants, controlled invasive weeds, and installed more than 100 different species of native flowers, shrubs, vines, grasses, and trees throughout the Park. Dense stands of common fennel that once invaded the slope adjacent to South Regatta Dr. have been removed and replaced with a diversity of native shrubs and wildflowers. Throughout the grassy area adjacent to the picnic tables, pollinator pods have been installed with vibrant flowers, native grasses, and sedges to attract pollinators and support monarch butterflies.

Invasive winged elm has been removed from along the waterfront slope and replaced with native wildflowers, grasses, shrubs, and vines that help prevent erosion. The riparian area east of the parking lot, previously choked by nonnative blackberry, has been expanded with more than 1,000 native shrubs, vines, and wildflowers.

Planned work in 2026 includes ongoing weed control, additional planting and seeding, and the installation of interpretive signage highlighting native plants, their cultural significance, and their importance to wildlife.

Glen Cove Waterfront Park has long been a special place for the Yocha Dehe Wintun Nation. Today, it also stands as a powerful example of what is possible when Tribal Nations, conservation partners, and engaged residents work together. The Nation extends deep respect and gratitude to Glen Cove Community Association, local volunteers, and community members whose care, participation, and commitment have helped steward this land — ensuring its cultural history and natural beauty can be enjoyed now and for generations to come.

Alert Solano Emergency Alert System

A Reminder from The Glen Cove Community Association

Alert Solano is the official emergency notification system for Solano County, California. It's used by local authorities to send urgent alerts and information. Receive alerts about:

- Wildfires and evacuations
- Missing persons
- Public safety threats
- Severe weather
- Community-wide emergencies
- Road closures

You can receive alerts via text, e-mail, phone call (landline or mobile), or the AlertSolano app.

Register or update your info at: www.alertsolano.com

During sign-up, you can:

- add multiple phone numbers or emails
- choose which cities or ZIP codes you want alerts for
- opt into specific alert types



How to sign up

Step 1: Go to the official website

Visit: <https://www.alertsolano.com>

You'll be redirected to the Everbridge system, which powers Alert Solano.

Step 2: Create your account

1. Click "Sign Up" (or "Create an account").
2. Enter your name, email, and create a password.
3. You'll receive a confirmation email; open it and click the verification link.

Step 3: Add your contact methods

You can choose multiple ways to be contacted:

- Mobile phone (text and voice)
- Home phone
- Email address

It's best to add both text and email so you don't miss alerts.

Step 4: Add your address

- Enter your home address in Glen Cove, Vallejo.
This ensures you only get alerts relevant to your neighborhood (like wildfire or evacuation notices).
- You can also add work or family addresses if you want alerts for those areas too.

Step 5: Choose your notification preferences

You can opt in to alerts such as:

- Evacuation warnings/orders
- Wildfires
- Severe weather
- Police activity
- Community alerts (road closures, missing persons, etc.)

You can decide how you want each type delivered (text, call, e-mail).

Step 6: Save and test

After finishing your setup:

- Click "Save" or "Finish"

You can send yourself a test alert to confirm everything's working.
